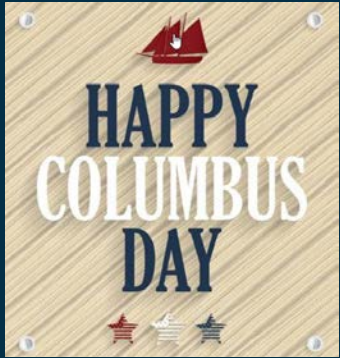

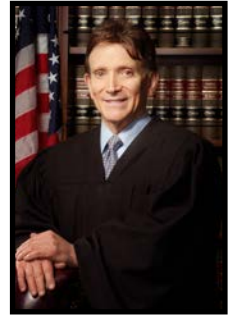

INVITATION FOR PUBLIC COMMENT ON THE REAPPOINTMENT OF JUDGE THEODOR C. ALBERT

The current term of the Honorable Theodor C. Albert, U.S. Bankruptcy Judge for the Central District of California, is due to expire in May 2019. The U.S. Court of Appeals for the Ninth Circuit is considering the reappointment of Judge Albert to a new 14-year term of office. The Court invites comments from the bar and public about Judge Albert's performance as a bankruptcy judge. The duties of a bankruptcy judge are specified by statute, and include conducting hearings and trials, making final determinations, and entering orders and judgments.

Members of the bar and public are invited to submit comments concerning Judge Albert for consideration by the Court of Appeals in determining whether to reappoint him. Anonymous responses will not be accepted. However, respondents who do not wish to have their identities disclosed should so indicate in the response, and such requests will be honored.

CM/ECF TIPS

Avoiding Duplicate Charges/Payments - Online Credit Card Payments

When making payments in CM/ECF via Pay.gov, please be reminded of the following:

- A. At no time during the payment process should you use the browser button. Doing so may result in a duplicate charge to the attorney's credit card.
- B. Please do not double-click the Submit Payment button at any time. Doing so may result in a duplicate charge to the attorney's credit card.
- C. After clicking Submit Payment, if the payment receipt screen does not display for whatever reason (computer malfunction, power outage, etc.), please **do not** attempt to submit payment again without checking your payment history or contacting the ECF Help Desk. Doing so may result in a duplicate charge to the attorney's credit card.
- D. Fees are due upon completion of a filing requiring a fee. If you choose to accumulate filing fees throughout the day, all fees must be paid by the end of the day in which the filings occurred. If the filing fees are not paid by the end of the day, the registered ECF User will receive a daily email reminder that payment is due and will be locked out of the CM/ECF system 24 hours after filing.
- E. To run the payments due report, click on **Utilities > Internet Payments Due**. If a payment or payments are due, the **Payment Summary** screen will display; select items to be paid and proceed with payment.
- F. To check your payment history, click on **Utilities > Internet Payment History**. Enter the date range, click **Run Report**, and the report will display.
