# SELF-HELP DESK NOW OPEN EVERY MONDAY!

The San Fernando Valley Self-Help Desk provides *pro* se debtors with access to bankruptcy information, forms, and counsel. Debtors and creditors, regardless of filing division, income, or chapter are welcome to use these services. The help desk is now open every Monday (except official holidays) from 1-3 pm.



In addition, the Clerk's Office is offering bankruptcy seminars at noon on the first Thursday of each Month, also at the San Fernando Valley Courthouse. In each seminar, a volunteer from the bar will talk about bankruptcy filing requirements and other useful information.

### HAVE YOU LOU'D YET?

After a successful pilot phase, the Court's electronic upload program, LOU, was released district-wide on November 19, 2007. Since the district-wide rollout of the Lodged Order Upload (LOU) program, approximately 850 orders have been electronically lodged. Each or the 21 judges in the Central District has received at least several orders uploaded through LOU, by 228 different attorneys.

LOU enables attorneys to electronically lodge orders in Microsoft Word format. Although it is a separate program from ECF. it is incorporated into the CM menu, making it easy for attorneys to find and select it. CIAO! converts the order to a PDF upon entry to the docket, thus saving time for staff, as scanning the order is not necessary. All electronically uploaded orders will also generate either an electronic or manual notice from the Bankruptcy Noticing Center (BNC) upon entry in the Court's Case Management (CM) system.

# **CM/ECF TIPS!**

#### On-line Manual

Did you know that step-by-step ECF filing procedures are available on-line? A hyperlink for the Online Manual will appear in the CM/ECF menu once you have logged into the system. We recommend you right-click on the hyperlink to open it in another window. That way, the ECF RoboHelp program will be automatically launched and you can search by keyword while still working on your petition, etc. in the other window!

#### **Avoid Duplicate Filings**

If the "receipt" (Notice of Electronic Filing) does not display immediately after the transaction has been submitted, always verify the filing in CM/ECF before re-filing the document. This rule also applies if the Pay.gov screen does not properly display to prompt for the payment of filing fees.

#### Upload the Creditor Matrix and Run the Judge/ Trustee Assignment

Always upload the Creditor Matrix and run the Judge/Trustee Assignment immediately after the petition has been filed.

#### Debtor(s) Address

To ensure the proper venue is assigned when the petition reflects both a physical and mailing address for the debtor(s), the physical address must be entered in the CM/ECF system.

### New and Revised Forms

Several Official Bankruptcy forms were added revised in December. as announced in Public Notices 07-015, 07-017. 07-018. and 07-019. Effective immediately, please use the revised forms 1, 3A, 3B, 4, 5,



6, 7, 9, 10, 16A, 18, 19, 21, 22A, 22B, 22C, 23, 24, as well as the revised local bankruptcy rules forms 240B, F 1010-1, F 4008-1.3, and F 4008-1.4, and the new form F 5010-1.1 M (Debtor's Motion to Reopen Case and For Extension of Time to File Debtor's Certification of Completion of Postpetition Instructional Course Concerning Personal Financial Management)

With respect to amended Official Bankruptcy Form 1 (the Voluntary Petition), the boxes on page 1 are revised to specifically require the redaction of both social security and individual taxpayer identification numbers for individual debtors, consistent with new Bankruptcy Rule 9037. CM/ECF filers may need to upgrade their petition preparation software and/or templates in order to file the revised Voluntary Petition. Additional information regarding the revised form can be found on the Judiciary's web site at www.uscourts.gov/bankform/index.html.

The new and revised forms are available on the Court's Web site: <a href="www.cacb.uscourts.gov">www.cacb.uscourts.gov</a>, under Forms/Rules/General Orders. They will also be available in printed format at the copy services at each division and at Intake in the Northern Division.

#### REQUEST FOR COMMENTS

The Judicial Conference's Committee on Rules of Practice and Procedure has issued a request for comments on the proposed amendment to Bankruptcy Rule 8002. Bankruptcy Rule 8002 is proposed to be amended to change from 10 days to 14 days as the deadline for filing a notice of appeal from a judgment, order or decree in a bankruptcy case. The proposed revision conforms to the time computation principles, which set deadlines of fewer than 30 days as multiples of seven days.



The Advisory Committee would be grateful to have the benefit of your views in determining whether the proposed 14-day deadline is appropriate and suitable to the needs of current practice, and whether consideration should

be given to the question of further extending the deadline in the future to make it consistent with the 30-day general civil appellate deadline imposed by Federal Rule of Appellate Procedure 4(a)(1). Comments should be submitted by February 15, 2008, to: rules\_comments@ao.uscourts.gov.
