JUDGE KWAN INDUCTION CEREMONY

Monday June 25, 2007 was a special day for the legal community of the Central District of California - Judge Robert N. Kwan was officially inducted as a United States Bankruptcy Judge. Judge Kwan's induction was the first ever held for a bankruptcy judge at the spectacular Ronald Reagan Federal Building and United States Courthouse in Santa Ana. Chief District Judge Alicemarie H. Stotler and Chief Bankruptcy Judge Vincent P. Zurzolo presided over the ceremony, with over 20 district and bankruptcy judges in attendance.

The Ceremony began with Chief Judge Stotler administering the Oath of Office. Then Judge Kwan's wife, Grace, and three daughters, Elizabeth, Margaret, and Catherine performed the Investiture of Robe. Remarks were made by Judge Kwan's former colleagues and friends, Assistant United States Attorneys Yoshinori H. T. Himel and Robert F. Conte, A. Lavar Taylor, Attorney at Law, Los Angeles County Bar president Charles E. Michaels, and Judge Kwan's sister, Deputy State Public Defender Susan Ten Kwan.

In his response, Judge Kwan thanked his family, colleagues and mentors who supported his career, especially speaking with great compassion about members of his family who paved the way for him, including his father and his uncles, who are also practicing lawyers. Judge Kwan stated he felt like George Bailey in *It's a Wonderful Life* as "the richest man in town" surrounded by his supportive friends and family and jokingly adding that he hoped he had some resemblance to the movie's star Jimmy Stewart.

The Ceremony was adjourned by Clerk of Court Jon D. Ceretto, with immediately following a lively reception with terrific food and sweeping views of Orange County. The reception was generously sponsored by the International Women's Insolvency and Restructuring Confederation, the Los Angeles Bankruptcy Forum, the Orange County Bankruptcy Forum, and the Orange County Bar Association Commercial Law & Bankruptcy Section.

CHANGES TO THE 9TH CIRCUIT BANKRUPTCY APPELLATE PANEL (BAP)

Judge Erithe Smith, who has been serving on the Bankruptcy Appellate Panel (BAP) since January 1, 2004, announced that she will step down from the BAP effective August 1, 2007. In the wake of her vacancy, the 9th Circuit has appointed Judge Meredith Jury to the Panel. Judge Jury will join Judges Christopher M. Klein of Sacramento, Randall L. Dunn of Portland, Dennis Montali of San Francisco, Jim D. Pappas of Boise, and Bruce Markell of Las Vegas, who will be replacing BAP Chief Judge Philip H. Brandt of Seattle.

CHAPTER 15 PROCEDURES AND REVISIONS TO LOCAL RULES AND FORMS

General Order 07-01, which summarizes new Chapter 15 procedures, became effective on June 5, 2007. You can read the order on the Court's Web site: www.cacb.uscourts.gov Under *General Orders*.

In addition, several Local Bankruptcy Rules and Forms will be revised effective July 2, 2007. Among others, the form of papers filed with the Court (Local Rule 1002-1) and the extension of time to file schedules, statements, and other documents (Local Rule 1007-1) will be affected. There is a new Local Rule (2081-1) relating to Chapter 11 procedures, and a revised Local Rule (3015-1) regarding Chapter 13 cases. 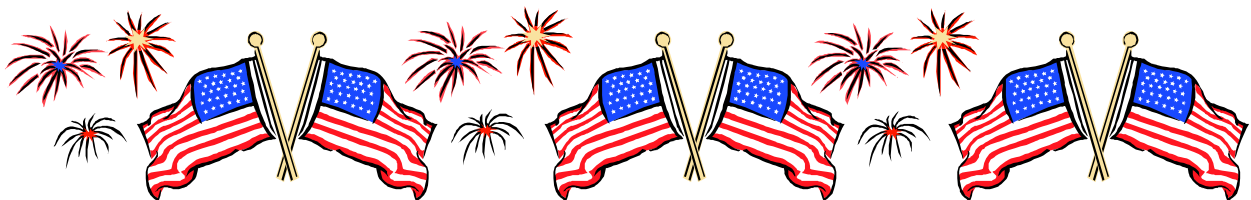

Judge Jury was delighted to be selected to serve on the BAP. She is particularly looking forward to serving along side other judges because, as she puts it, "the dynamic of discussing and deciding an issue with three judges involved is significantly different from what we do in the courtroom". BAP cases are heard by judges sitting in three-judge panels and each judge is precluded from hearing matters arising from their own bankruptcy district. Judge Jury also welcomes the opportunity to write more opinions and to clarify some of the ambiguities in BAPCPA.
