ELECTRONIC ORDER LODGING PILOT BEGINS

On August 20, 2007, the Court began piloting an enhancement to ECF that accepts electronically lodged proposed orders using our court-developed calendaring program, CIAO!. During the pilot phase, which is scheduled to last approximately 30-45 days, proposed orders can only be uploaded for cases and adversary proceedings assigned to Chief Judge Vincent P. Zurzolo and Judge Alan M. Ahart. Once the pilot phase is successfully concluded, the upload of proposed orders into the ECF system will replace the current process by which proposed orders are physically lodged with the Court.



Proposed orders must be uploaded into ECF as a Microsoft WORD 2003 document. This enables the Court to edit or modify the proposed order, as applicable, a critical feature for our Court. Once uploaded, the orders can be reviewed by the Clerk's Office for compliance with the local rules and administrative procedures, and then routed electronically to the judge. Once the judge approves the order for entry, the judge's electronic signature will be affixed to the last page of the order and the order will be entered on the case docket in PDF format.

PROPOSED AMENDMENTS PUBLISHED FOR PUBLIC COMMENT

The Judicial Conference Advisory Committees on the Appellate, Bankruptcy, Civil, and Criminal Rules have proposed amendments to federal rules and Official Forms, and requested that the proposals be circulated to the bench, bar, and public for comment. Most of the amendments are proposed in conjunction with the adoption of uniform time-computation rules. The public comment period ends on February 15, 2008. HIGHLIGHTS OF THE ECF EVALUATION

Electronic Case Filing (ECF) has increased availability and efficiency in many ways; nevertheless, mastering a new system does not come without practice, and a little trial and error. In August 2007, the Central District of California surveyed attorneys in order to gather useful feedback in support of the Court's effort to provide service of the highest quality.

Survey questions focused on three main components of ECF, the helpfulness of Court resources, the training sessions, and overall user satisfaction. All attorneys who filed using ECF at least once between January 1 and June 30, 2007 were sent the survey. Distribution was done via email, and the response rate was over 40%.

We are delighted to hear from so many of you that the ECF Help Desk is "Top Notch." Ninety-eight percent of respondents found the Court's ECF Help Desk to be helpful, with nearly 50% of all respondents describing the ECF Help Desk as "outstanding" and another 31% as "very good." Additionally, 74% of respondents reported that ECF training classes were effective or of high quality, and 68% reported that the length of the training was about right.

Respondents confirmed our suspicion that docketing is the most challenging aspect of ECF. About half of the respondents suggested that selecting docket event codes was the single-most difficult aspect of ECF, and that any future training should focus on docketing. Still, about one-third of respondents said they had NO PROBLEMS with any aspect of ECF, and about one-quarter said they were comfortable with ECF just the way it is! We are still analyzing the responses and hope to make improvements based on the specific suggestions received.

TRANSCRIPT REDACTION PROCEDURES REVISED TO REQUIRE REVIEW BY ATTORNEY

The Judicial Conference has recently adopted revisions to the transcript redaction procedures to require party's attorneys to review a transcript for personal information that should be redacted under the Judicial Conference's privacy policy.

- 1. Each party's attorney is required to review a transcript for information that should be redacted under the Judicial Conference's privacy policy: Social Security numbers should be redacted to only the last four digits; birth dates should contain only the year of birth; individuals known to be minors should be referred to with initials; and financial account numbers should be redacted to the last four digits.
- 2. Within five business days of a court reporter's delivery of the transcript to the clerk of court, an attorney must file a notice with the court of his or her intent to request redaction of such information from the transcript. An attorney is responsible for reviewing the opening and closing statements made on behalf of the party he or she represents, any statements made by the party, and the testimony of any witnesses called by the party. If no notice is filed during this five-day period, the Court may assume that redaction of personal data is not necessary, and may make the transcript electronically available to the public.
- 3. Once an attorney has filed a notice of intent to request redaction, he or she has 21 days to review the transcript and submit to the court reporter of transcriber a list of the places in the transcript where personal data to be redacted appears. The Court may order this time extended, for good cause shown. The Court reporter or transcriber must redact the identifiers, as directed by the party, and then refile the redacted transcript. Also during the time period, an attorney could, by motion, request that additional information be redacted. No remote electronic public access to the transcript will be allowed until the Court has ruled on any such motion.

SAN FERNANDO VALLEY DIVISION TO OPEN SELF-HELP DESK

On September 17, 2007, the San Fernando Valley Division will open a Self-Help Desk in the Intake area to provide *pro se* debtors with access to bankruptcy information, forms, and counsel. One afternoon each week, a trained paralegal will be provide walk-in members of the public with this service, but will not provide legal advice.

A flyer from the Self-Help Desk will be provided to all *pro se* filers to encourage filers with specific issues to seek the advice of counsel and warn of the common pitfalls

that lead to case dismissal. The self-help program will also feature monthly seminars where a volunteer from the bankruptcy bar will provide information about filing bankruptcy. In the future, a monthly seminar will be held for creditors.

The Self-Help Desk is the result of a collaborative effort between the Bankruptcy Court, Neighborhood Legal Services of Los Angeles County, the Central District Consumer Bankruptcy Attorney's Association, and the San Fernando Valley Bar Association Attorney Referral Service. The various stakeholders were brought together by Bankruptcy Judge Maureen A. Tighe. Funding was provided for the first year by a grant from the Central District's Attorney Admissions Fund.

Judicial Employee Presented Award for Excellence in Alternative Dispute Resolution

Treating obstacles as challenges instead of barriers was a key factor in Susan M. Doherty receiving the prestigious Robert F. Peckham Award for Excellence in Alternative Dispute Resolution (ADR) at the 2007 Ninth Circuit Judicial Conference in Honolulu, Hawaii. The award acknowledges judicial employees who have advanced the delivery of effective court-based ADR programs in the Ninth Circuit.



Senior Circuit Judge Dorothy W. Nelson, Chair of the Ninth Circuit's Alternative Dispute Resolution Committee presented the award to Ms. Doherty.

Ms. Doherty has an extensive background in the ADR program. She was instrumental in the initial development and implementation of the program in 1994 after being hired as a career law clerk for Bankruptcy Judge Barry Russell. She also served as the program coordinator until taking a leave of absence in 1999. In 2004, she resumed her positions with Judge Russell and the mediation program.
